ASSEMBLED ACP DOCUMENTS RELATED TO 401 REVIEW, EROSION AND SEDIMENT CONTROL, STORMWATER MANAGEMENT, AND GEOHAZARDS

The publicly accessible read-only Dropbox folder, [ACP-401-ESC-SWM](#), includes the following subfolders. Note that many documents address multiple subjects in addition to the subfolder topic. The assembled documents were mostly obtained from the FERC Docket for the Atlantic Coast Pipeline and from the Virginia Department of Environmental Quality. The primary purpose of this compilation is to support public and expert review of Virginia and West Virginia 401 Water Quality Certifications for the ACP. 1. ACP GENERAL PROJECT DESCRIPTION

ACP'S Resource Report 1 General Project Description (submitted to FERC Sept. 2015) (*Note: much of this info was revised or supplemented in later submissions*)

2. ACP CONSTRUCTION OPERATIONS AND MAINTENANCE PLAN

Dominion describes this document as its Erosion and Sediment Control Plan. It does not provide site-specific plans, and it seems to apply mainly to Forest Service lands. The folder includes multiple versions and questions presented by the Forest Service

3. HIGH-HAZARD HIGH-EXCAVATION AREAS

This folder includes ACP's Geohazard Report and later addendum. It includes a series of questions presented by the Forest Service and Dominion Responses. Site-specific details for construction are provided for two sections of the proposed pipeline (0.3 and 0.1 miles in length) in the National Forests.

4. KARST HYDROLOGY

This folder includes Dominion's karst survey information and general plans for construction in karst areas. Additional reports and comments providing information on karst features and concerns are provided.

5. WVDEP STATE PERMITTING

Dominion submissions to the W.Va. Department of Environmental Protection including the ACP 401 application and the ACP Stormwater Pollution Prevention Plan.

6. VADEQ STATE PERMITTING

Material related to 401 certification and Annual Standards and Specifications and related correspondence between Dominion and the Va. Department of Environmental Quality. Much of this material was provided in response to Freedom of Information Act requests. 7. VADEQ DEIS COMMENTS

This folder includes the Va. Department of Environmental Quality assembly of state natural resource agency comments on FERC's Draft Environmental Impact Statement. Dominion's responses to those comments are also provided.

FERC's general guidelines for pipeline construction erosion and sediment control and stream and wetland crossing, plus Dominion's proposed modifications.
